1. **India-UK CETA unlocks \$32 billion trade corridor, set to boost MSME exports.**

India and the UK on July 24, 2025, signed the Comprehensive Economic and Trade Agreement (CETA) in London, marking India's 15th and one of its most wide-ranging trade pacts. "In FY25, India exported \$14.5 billion worth of goods to the UK. Of this, \$6.5 billion, or 45%, comprising textiles, footwear, carpets, automobiles, seafood, and fresh fruits like grapes and mangoes, will now enter duty-free, compared to earlier tariffs of 4-16%," Mr. Ajay Srivatsava, Founder of the Global Trade research Institute said. The remaining \$8 billion of Indian exports—petroleum, pharmaceuticals, diamonds, and aircraft components—already enjoyed zero-duty access. The UK will now eliminate tariffs on all Indian goods except select agricultural items such as rice.

2. **India on track on become Third Largest economy by 2028 : Morgan Stanley.**

India is on track to become the world's third-largest economy by 2028 and more than double its GDP to \$10.6 trillion by 2035, according to the latest report by Morgan Stanley. The report also highlighted the pivotal role that Indian states will play in steering this economic transformation.

3. **Clean energy push: Govt races to build transmission firms to meet 2030 goal.**

India has made rapid progress in adding renewable power capacity – its non-fossil fuel capacity of 242.8 GW accounts for about half of the total installed capacity of 484.8 GW – but the transmission infrastructure has not kept pace. India is targeting 500 GW of clean energy capacity by 2030.

4. **India's farm sector poised for gains as trade deal enhances access to UK market**

India has protected the interests of domestic farmers by excluding dairy products, edible oils, and apples in the free trade agreement (FTA) with the UK while securing zero duties on 95 per cent of agriculture and processed food items. On the other hand, Indian staples like turmeric, pepper, and cardamom; processed goods like mango pulp, pickles, and pulses; and marine products such as shrimp and tuna will enjoy duty-free access in the UK market. This will lead to a reduction in the landed cost of these Indian products in the UK market, boosting India's export and enhancing the income of domestic farmers.

5. **India's achieves 20 pc ethanol blending target 5 years ahead of schedule : ISMA**

India has achieved its target of 20 per cent ethanol blending with petrol five years ahead of schedule, the Indian Sugar & Bio-energy Manufacturers Association (ISMA) said. The achievement represents dramatic growth from the modest 1.5 per cent blending rate when the program began in 2014 under Prime Minister Narendra Modi's administration, ISMA said in a statement.

6. **India's pharma exports rise 9.3% to \$30.5 billion in FY25; complex generics and global expansion drive growth**

India's pharmaceutical exports reached US\$30.5 billion in FY2025, marking a 9.3% increase from the previous year, according to a new report by Rubix Data Sciences, a leading provider of risk management and monitoring solutions. The report projects that the country's pharma exports could double to US\$65 billion by 2030.

India's Unified Payments Interface (UPI) has emerged as the world's most-used real-time digital payment system, powering over 50% of global instant transactions, according to the International Monetary Fund (IMF). With 18 billion monthly transactions and over Rs 24 lakh crore processed in June 2025.

India's digital payment wave is spreading beyond borders. UPI is now active in the UAE, Singapore, Bhutan, Nepal, Sri Lanka, France, and Mauritius. France marked UPI's debut in Europe, and India is working to expand it to BRICS nations.

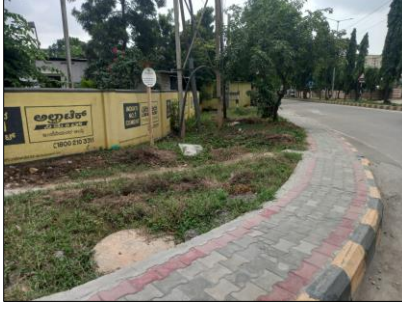

Agenda: update on Employment linked Incentive (ELI) Scheme & Followed by member interaction with Hon'ble H C Balakrishna.

Total 130 participants attended the meeting.

Key Highlights on ELI Scheme:

- Mr. Suresh Kumar from Deloitte provided detailed updates on the Labour Codes, Karnataka Gig Worker Regulations, and other relevant policy changes.
- **Labour Codes (India):** The four new Labour Codes—on Wages, Industrial Relations, Social Security, and Occupational Safety—aim to streamline and modernize India's labour laws, ensuring better worker protection and ease of compliance for employers.
- **Karnataka Gig Worker Law (2025):** Karnataka enacted India's first comprehensive law for platform-based gig workers, establishing a Welfare Board, mandatory welfare fee (1–5%), insurance coverage, fair contracts, and grievance redressal mechanisms.
- **Platform Obligations:** Companies like Uber, Swiggy, and others must register workers, ensure transparent contracts, contribute to the welfare fund, and provide clear communication, including human support channels and algorithmic transparency.

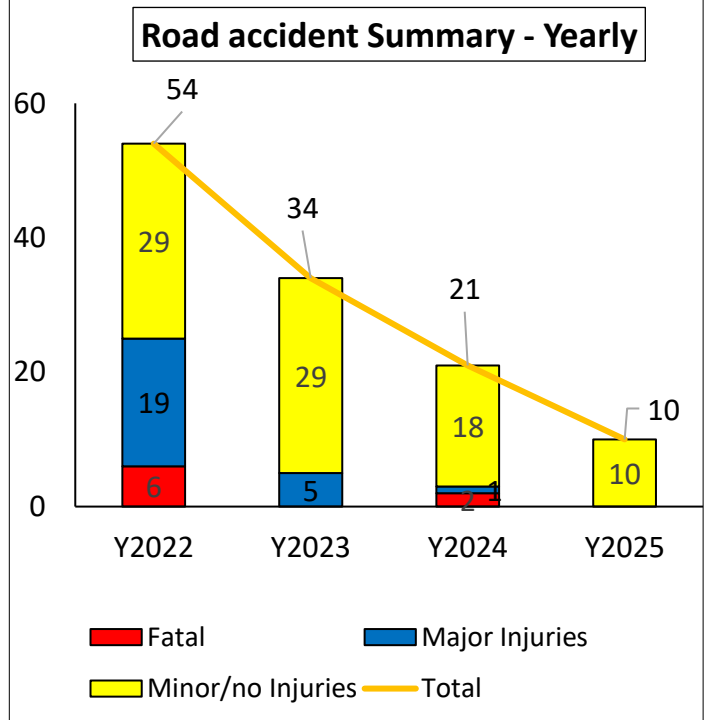

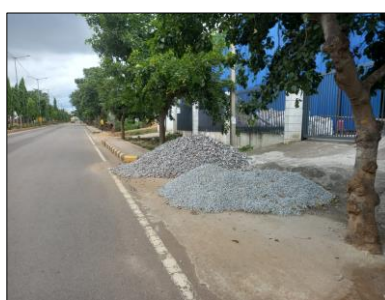
