1. **Cabinet approves BioE3 (Biotechnology for Economy, Environment and Employment) Policy for Fostering High Performance Biomanufacturing**

The Union Cabinet cleared a proposal to bolster biotechnology-based manufacturing, called BioE3 (Biotechnology for Economy, Environment and Employment) Policy for Fostering High Performance Biomanufacturing. To be steered by the Department of Biotechnology, the aim is to have it catalyse a technology revolution “just as the IT industry revolutionised life in the 1990s”, an internal note said.

2. **Karnataka Cabinet okays Tunnel Road, Sky Deck Projects in Bengaluru**

The cabinet approved Bengaluru’s first tunnel road project which is projected to cost a staggering Rs. 12, 690 crore and is aimed at resolving Bengaluru’s traffic woes. The cabinet also green signalled the construction of a 250-metre sky deck. The first phase of the tunnel road project envisages building a twin tube, 18 km corridor from Hebbal flyover to Central Silk Board junction.

3. **India, Australia conclude tenth round of trade talks, next meeting in November**

India and Australia held ‘intensive discussions’ on a wide range of issues, including goods, services and digital trade, and underscored the commitment to strengthen and enhance economic partnership during the 10th round of Comprehensive Economic Cooperation Agreement (CECA) negotiations between the two sides, an official statement said.

4. **Malaysia is an important partner for India in the ASEAN and Indo-Pacific regions**

India and Malaysia decided to upgrade ties to a ‘Comprehensive Strategic Partnership’ on Tuesday, during talks between Prime Minister Narendra Modi and Malaysian Prime Minister Anwar Ibrahim, as part of a visit aimed at moving beyond several years of tensions over a number of issues. The two leaders announced the decision to upgrade the 2010 Strategic Partnership, that had been made an ‘Enhanced Strategic Partnership’ in 2015, along with a number of agreements and MoUs signed in their presence, including on workers’ mobility, digital technology, culture, tourism, sports and education.

5. Simplify income tax for citizens, Sitharaman tells tax department

“Tax notices need to be simplified so that people understand them better. Can we explore issuing simple, easy-to-understand notices? FM Sitharaman asked. Moreover, the FM asked income tax department to refrain from using “threatening language” in tax notices. Let the experience of filing tax return on the first day be as good as filing it on the last day. We have to ensure that threatening language in tax notices and messages is avoided,” said the FM.

Prime Minister Narendra Modi, congratulated Reserve Bank of India's (RBI) Governor, Shaktikanta Das for bagging an A+ grade rating in the Global Finance Central Banker Report Cards 2024. Prime Minister in a post on social media "X" said, "Congratulations to RBI Governor Shri @DasShaktikanta for this feat, and that too for the second time. This is a recognition of his leadership at the RBI and his work towards ensuring economic growth and stability."

7. Govt proposes to introduce new rules to clean up contaminated sites

The ministry of environment, forest and climate change (MoEFCC) has proposed to introduce rules to clean up lands contaminated by hazardous substances.

The ‘Remediation of Contaminated Sites Rules, 2024’ will cover the gaps in the Environment (Protection) Act, 1986, and various schedules of Hazardous and other Wastes (Management & Transboundary Movement) Rules, 2016, and in the Public Liability Insurance Act, 1991, the ministry said in a 21 August draft notification.

The new rules were published in The Gazette of India on Thursday, and will come into effect after 60 days.

8. India plans to build 50 e-commerce export hubs

The Indian government has recently set a goal to create about 50 e-commerce export zones during the next five years, as the country’s e-commerce exports are at a rather low level – only Rs 41000 crore. China exports e-commerce goods for about Rs 25 lakh crore.

9. Balance compliance with ease of doing business, tax officials told

Tax officers should balance the need for enforcing compliance with the need to ensure ease of doing business in the country, senior finance ministry officials said at a national conference of the indirect tax authority.

At the second edition of the ‘national conference of enforcement chiefs of state and central GST formations’ held in the capital, revenue Secretary Sanjay Malhotra stressed on the importance of maintaining “a fine balance between enforcement actions and ease of doing business,” an official statement said.

10. India will wear a grand necklace of industrial parks

India will create a golden quadrilateral of industrial parks that will lift investment further, commerce and industry minister Piyush Goyal said, while pledging more measures to help industry grow. The minister said a policy for the ecommerce sector is being worked on, brushing aside concerns that the reform momentum was faltering because a coalition government was at the helm. "Our effort is to create a web of industrial parks across the country... This golden quadrilateral of industrial parks will add to investments."

11. ICRA sees Q1 GDP growth at six quarter low

India's GDP growth is likely to have slowed to a six-quarter low of 6% in the April-June period, rating agency ICRA reckoned, citing a decline in urban consumers' confidence levels as well as a dip in government capital expenditure.

12. Business activity slips in August as Manufacturing eases: Survey

India's manufacturing PMI fell to a three-month low of 57.9 in August, while the services PMI slightly increased to 60.4. India's economic activity slipped slightly in August as new order growth for the manufacturing sector slowed, a flash survey by HSBC Holdings Plc showed. The manufacturing purchasing managers' index dropped to a three-month low of 57.9 from 58.1 in July, while the services purchasing managers' index rose to 60.4 from 60.3 in the previous month. That resulted in the composite index falling to 60.5 from 60.7 in July, the lowest reading since May.

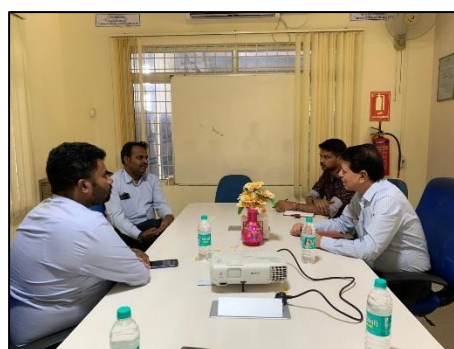

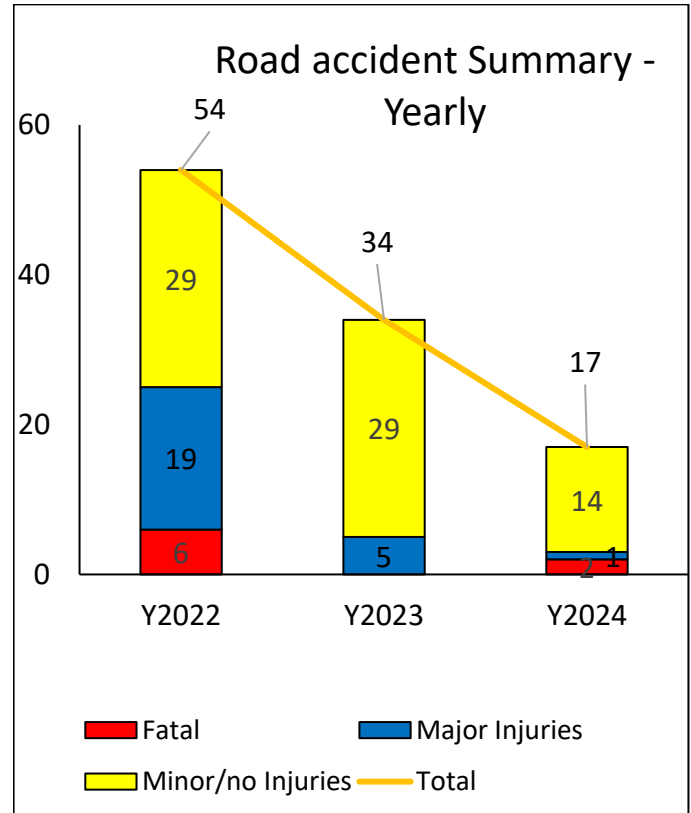
